



LIQUID WASTE HAULER DISCHARGE PERMIT AGREEMENT

This Liquid Waste Hauler Discharge Permit is granted in accordance with the City of Hollister Ordinance N.1046(Municipal Code 13.06) and with the following provisions:

1. The Liquid Waste Hauler shall abide by all applicable provisions of the City of Hollister Ordinance No. 1046 (Municipal Code 13.06)
2. This permit shall not be reassigned or transferred.
3. The hauled liquid wastes conveyed to the City of Hollister facilities must be of residentially or commercially domestic origin and must comply with the City of Hollister Liquid Waste Discharge Requirements.
4. Disposal of any waste from grease traps and industrial septic tanks is prohibited.
5. The Liquid Waste Hauler shall fill out a Hollister Liquid Waste Hauler Manifest form prior to discharge (example attached).
6. The requirements prescribed herein do not authorize the commission of any act causing injury to the property of another nor protect the discharger from his liabilities under Federal, State or local laws, nor guarantee the discharger a capacity right in the facilities of the Hollister Water Reclamation Facility.
7. The Liquid Waste Hauler shall permit the City of Hollister:
 - a. Access to copy any records required to be kept under terms and conditions of the permit
 - b. Sampling of any discharge
8. The Liquid Waste Hauler shall obey all Hollister Water Reclamation Facility safety and speed regulations and be licensed by the State of California Department of Motor Vehicles.
9. The Liquid Waste Hauler shall maintain his/her tank truck with its discharge control equipment in good working order to allow its load to be discharged in the most sanitary manner possible at the City of Hollister receiving facility.
10. The Liquid Waste Hauler shall be responsible for removal of all material attributed to his/her discharge from the surface of the liquid waste receiving facility and leave the area clean. Failure to comply with this requirement may result in cancellation of this permit.
11. If for any reason the Liquid Waste Hauler is unable to comply with any of the provisions of the permit, he/she shall notify the City of Hollister Reclamation Facility by telephone (831)637-7103 as soon as he/she or his/her agents have knowledge of the condition and confirm this notification in writing within five (5) days of the telephone notification. The written notification shall include pertinent information explaining reasons for the non-compliance, shall indicate what steps were taken to correct the problem and the dates thereof, and what steps are being taken to prevent the problem from recurring.
12. This permit may be terminated or modified for cause, including but not limited to:
 - a. Violation of any term or condition in this permit
 - b. Obtaining this permit by misrepresentation or failure to disclose fully relevant facts
 - c. A change in any condition upon which their permit was issued
 - d. Failure to pay liquid waste permit and discharge fees

This permit will expire on December 31st of the current year. This permit is subject to the conditions in the City of Hollister Ordinance No. 1046 (Municipal Code 13.06) and the renewal of all State, County, and local permits and licenses and the maintenance of a satisfactory payment record with the City of Hollister.
