6.b. LAFCO Presentation

Jennifer Stephenson, Executive Officer of the San Benito County Local Agency Formation Commission (LAFCo) provided a presentation on unincorporated islands that are present within the city of Hollister.

Ms. Stepheson updated the committee on LAFCo's current policy revision, highlighting several draft proposals. These include promoting the annexation of islands, having LAFCo support the streamlining of the annexation process and encouraging city-county joint planning and island areas to eliminate confusion.

6.c. Discussion on addressing homeless encampments

Celina Stotler, County of San Benito Integrated Waste Manager, provided an update on the County's working group efforts to address encampments, which includes collaboration among various county and city departments.

Enrique Arreola, Deputy Director of Community Services and Workforce Development for San Benito County outlined the agency's goals and services aimed at supporting homeless individuals.

Sherriff Taylor provided a report on the 2024 River Census of the San Benito River.

Hollister City Manager David Mirrione expressed gratitude for the partnership through the JPA with the County of San Benito Integrated Waste Manager, noting that the city contributed 65% of the funding for recent activities. Mirrione also stated that the city redirected most of its Permanent Local Housing Allocation funding to help support the County's homeless shelter.

Hollister Police Chief Reynoso updated the committee on the City of Hollister's cleanup efforts within its jurisdiction, emphasizing the city's commitment to working closely with the county.

Supervisor Curro inquired about the possibility of installing cameras in areas prone to illegal dumping, as well as using drones to monitor and track activity.

Hollister Police Chief Reynoso shared that the city's network of cameras has been highly effective, noting that placing them along the river has improved surveillance and helped with identification efforts.

Sheriff Taylor explained how the county has benefited from the City of Hollister's cameras and, as a result, is now working to install their own, with plans to set up 10 cameras.
