

CALGREEN COMPLIANCE

STEP - 1

- CALGreen Code requires 65% of Construction & Demolition (C&D) waste to be recycled.

STEP - 2

- Review C&D Recycling Guide and Approved Haulers to plan for recycling services.
- Complete C&D Recycling Plan
- C&D Recycling Plan must be completed prior to issuance of your permit

STEP - 3

- Contact your chosen recycler and/or hauler to arrange recycling for your site.
 - All haulers must have a signed Non-Exclusive Franchise Agreement on file to conduct business in San Benito County. Consult the Approved Haulers handout for more information.
- Source separating C&D Material may save you money. C&D processors may charge lower prices for clean C&D material as opposed to mixed C&D material.
- Ensure 65% OF ALL C&D WASTE IS RECYCLED, and KEEP ALL WEIGHT TAGS for verification.

STEP - 4

- Complete Post Construction Report – on reverse of Recycling Plan
