## SPECIAL INSPECTION AND TESTING AGREEMENT

TO APPLICANTS OF PROJECTS REQUIRING SPECIAL INSPECTION OR TESTING PER CHAPTER 17 OF THE 2019 CALIFORNIA BUILDING CODE

BEFORE A PERMIT CAN BE ISSUED: The owner or his representative, on the advice of the responsible Project Engineer or Architect, shall complete, sign and submit two (2) copies of the attached Structural Tests and Inspection Schedule to the City of Hollister Building Division staff for review and approval.

The owner and general contractor, where applicable, shall also acknowledge the following conditions applicable to

#### Structural Tests and Inspection Schedule.

- 1. Contractor is responsible for proper notification to the Inspection or Testing Agency for items listed.
- 2. The testing laboratory is the only one that should take test samples and transport them to their laboratory.
- 3. Copies of all laboratory reports and inspections are to be sent directly to the City of Hollister Building Division office by the Testing Agency.
- 4. Inspection agency to submit names and qualifications of on-site special inspectors to the Building Division and provide copies of certification at job site.
- 5. It is the responsibility of the contractor to review the Building Division approved plans for additional inspection or testing requirements that may be noted. A pre-construction conference at the job site is recommended to review special inspection procedures. The special inspector shall use only Building Division approved drawings.
- 6. BEFORE A CERTIFICATE OF OCCUPANCY PERMIT CAN BE ISSUED, the inspection agency shall submit a statement noting that all items requiring testing and inspection have been fulfilled and reported. Those items not tested and/or inspected shall be noted in this statement. A copy of the statement shall be maintained at the job site for the building inspector's review prior to final inspections.
