6.b. Discussion on options to promote San Benito County as the "Home of Pinnacles National Park".

Pinnaces National Park Superintendent Blanca Stransky provided a presentation regarding the strategic planning and future plans for the Pinnacles National Park to promote partnerships and connect to the surrounding communities. Superintendent Stransky reported data was previously compiled regarding the spending patterns of visitors to Pinnacles.

Mayor Casey requested a copy of the report referenced by Superintendent Stransky.

Supervisor Kosmicki inquired about partnerships between other national parks and their surrounding communities.

Superintendent Stransky provided information regarding branding and promotion of other national parks and their partnerships with the surrounding communities and nearby universities and schools, including events, marketing campaigns, etc. Superintendent Stransky stated Pinnacles needs to be promoted in a sustainable way to protect the wilderness there and minimize vandalism.

Supervisor Kosmicki commented on the desire to bring visitors to the entire region and its attractions, such as wineries and Fremont Peak.

Superintendent Stransky stated there is currently no visitors center at Pinnacle to provide interpretive exhibits, but they are open to highlighting other regional attractions on their website. Superintendent Stransky supported highlighting the Pinnacles experience starting when visitors arrive in surrounding communities, including requesting CalTrans improve signage along the route to Pinnacles and improving the roadways.

Supervisor Kosmicki supported reforming the Pinnacles Partnership organization.

San Benito High School District Superintendent Shawn Tennenbaum provided information on Hollister High School's dark sky initiatives and programs.

Valerie Egland with REACH supported local agencies and organizations partnering with Pinnacles to support an increase in visitors to the park and region.

Michelle Leonard with the San Benito County Chamber of Commerce spoke regarding the Chamber's previous work to support tourism in the County. Ms. Leonard supported a dedicated tourism program to help connect visitors to businesses in the County, such as hotels, restaurants, etc.

No speakers present.

Superintendent Stransky commented on potential grant opportunities to support partnership programs and events, such as a California Condor Festival.

Supervisor Kosmicki suggested the various jurisdictions consider budget funds to support a marketing campaign. Supervisor Kosmicki supported renaming Highway 25 Pinnacles National Park Highway at least from the Highway 101 corridor to Pinnacles.

Mayor Casey reported on the Visit San Benito tourism organization and their efforts.

Superintendent Stransky requested contact information for potential partners and community members related to tourism, transportation, etc.
