### MEETING MINUTES Tuesday, February 27, 2024

#### CALL TO ORDER

Commissioner Rodriguez called the regular meeting of the Hollister Parks & Recreation Advisory Commission of the City of Hollister to order at 6:30 p.m.

#### PLEDGE OF ALLEGIANCE

Commissioner Rodriguez led the Pledge of Allegiance

**Roll Call:** Commissioner Rodriguez, Commissioner Barraza, and Commissioner Castro present

Chair Graziano and Commissioner Vicky Montoya resigned prior to the meeting.

#### VERIFICATION OF AGENDA POSTING

Commissioner Rodriguez reported the agenda for the Hollister Parks & Recreation Advisory Commission of the City of Hollister regular meeting of Tuesday, February 27, 2024, was posted on the bulletin board at City Hall on February 23, 2024 at 12:00 p.m. per Government Code Section 54954.2.

#### PUBLIC COMMENT

Mr. Drummond from San Juan Bautista commented that the Skate Park had been cleaned and graffiti removed. Mr. Drummond requested the curb inside the skate park be repaired and the area around the park be cleaned.

#### CONSENT AGENDA

There were no speakers for the consent agenda items.

Commissioner Castro moved, and Commissioner Barraza seconded the motion to approve the minutes from the Hollister Parks & Recreation Advisory Commission of the City of Hollister regular meeting of Tuesday, January 30, 2024. Motion carried 3-0-0.

#### COMMISSION BUSINESS

##### 1. VOTE FOR NEW CHAIRPERSON AND VICE CHAIR

Commissioner Castro moved, and Commissioner Barraza seconded the motion to appoint Commissioner Rodriguez as the new Committee Chairperson . Motion carried 3-0-0.

Commissioner Rodriguez moved, and Commissioner Castro seconded the nomination to nominate Commissioner Barraza as Commissioner Vice Chair. Motion carried 3-0-0.

There were no speakers present.

#### **STAFF AND COMMISSIONER REPORTS:**

Interim Parks & Recreation Department Director Tina Garza provided an update on renovations at Dunne Park, including resurfacing of the tennis and pickleball courts. Ms. Garza reported there will be a ribbon-cutting for the courts once the work is complete. Ms. Garza provided an update on various other projects, including proposed reroofing of the BBQ area at Vista Park Hill; remodel of the Pauline Valdivia Memorial Community Center interior through funds provided by a private donor for the interior remodel; and exterior beautification of the Community Center by the City. Ms. Garza reported on upcoming community events, including the St. Patrick's Day Dash and photos with the Easter Bunny and an Easter Egg Hunt at Dunne Park.

Chair Rodriguez suggested the Commissioners should work to get the word out to the community and Council regarding the need for more commissioners. Chair Rodriguez suggested the Commission create an ad hoc committee to discuss items relating to the skate park.

By consensus, the Commission decided to bring an item forward to create an ad hoc committee related to items for the skate park.

Chair Rodriguez moved, and Commissioner Castro seconded the motion to adjourn the meeting at 7:00 p.m. Motion carried 3-0-0.
